(15) Description of equipment:

The intrinsically safe, rugged tablet computer IS910.1 with efficient Octa-Core processor has been designed for use in explosion hazardous areas of zone 1 and 21.

The tablet computer provides numerous technologies like 4G (LTE), NFC, GPS, Wi-Fi and Bluetooth. Equipped with a SD card, camera and IR camera (optional in each case), vibration, sensors, amplified speaker and option key, which allows the allocation of user specific functions or applications.

Electrical data:

Supply The tablet IS910.1 has a fixed installed rechargeable battery.

Interfaces Opening the interface covers in explosive atmospheres is not permitted.
